Executive Summary

Correia Custom Farming Inc. respectfully submits this proposal to lease and responsibly manage approximately 408 acres of City-owned open land located near Highway 99 and Highway 198 in Visalia, California. Our proposal focuses on responsible agricultural production, soil improvement, and careful water management while protecting the interests of the City of Visalia. The land will be actively farmed using rotational crops that improve soil health while maintaining the property in excellent condition.

Company Overview

Correia Custom Farming Inc. is a Tulare County-based agricultural management company with extensive experience in row crop production, orchard management, irrigation operations, and agricultural land stewardship throughout California's Central Valley. As a third-generation family farming operation, our company has deep roots in the local agricultural community and a long-standing commitment to responsible land stewardship. We manage large-acreage farming operations using modern agricultural equipment and experienced personnel to implement efficient, responsible, and sustainable farming practices while maintaining a high standard of property management.

Experience and Qualifications

The company has extensive experience managing farmland throughout Tulare County including row crops, almonds, walnuts, and other agricultural operations. Correia Custom Farming Inc. specializes in soil fertility programs, irrigation management, water conservation, and farming operations designed to maximize productivity while maintaining soil health. Our company is very familiar with the property and have been farming dry land wheat on this location for the last 2 years.

Property Description and Understanding

The City-owned property consists of approximately 408 acres of open agricultural ground. Correia Custom Farming Inc. understands the importance of maintaining the land in productive condition while protecting the City's interests. Active farming ensures weed control, soil health, and long-term land productivity.

Proposed Agricultural Plan

The proposed agricultural plan is designed to maintain the property in productive agricultural use while managing the risks associated with dryland farming. Based on current commodity prices, dryland farming alone provides limited economic viability and is highly dependent on seasonal rainfall. In the event of a dry spring, the property may not have the ability to produce a marketable crop. Allowing the use of surface water when available helps reduce this risk by providing a more reliable water source that can support productive crop growth and justify the cost of necessary farming inputs. The use of available surface water supports regional groundwater sustainability objectives under SGMA. Maintaining active farming on the property ensures proper land stewardship, including weed control, field maintenance, and overall property upkeep, while preserving the long-term productivity and value of the land. These farming practices will help to maintain weeds on the property as well as mitigate dust. All agricultural activities will comply with state and local regulations.

Water Management and SGMA Compliance

Water management will follow all applicable regulations and groundwater sustainability requirements. During the duration of the lease, the property will be added to the lessee's water management account. The lessee will manage all SGMA compliance requirements associated with the property and will be responsible for all fees related to groundwater sustainability programs. Surface water may be utilized during flood release events or through privately owned surface water shares that do not negatively impact the City. When available, the use of surface water prevents the property from being classified as groundwater-dependent, thereby avoiding higher groundwater assessments under the Mid-Kaweah Groundwater Sustainability Agency (GSA). The beneficial use of flood-release surface water also provides an opportunity to recharge the underlying aquifer, supporting regional groundwater sustainability objectives established under the Sustainable Groundwater Management Act (SGMA). This practice will have no impact on the City of Visalia's water account or allocation, as no City water supplies are required. Instead, it generates regional benefits by improving groundwater recharge, strengthening aquifer reliability, and supporting long-term water sustainability for the surrounding community.

Infrastructure and Improvements

Temporary agricultural improvements such as irrigation infrastructure or field preparation improvements may be installed as necessary to support farming operations. All improvements will comply with City regulations and will be coordinated with the City as required under the lease agreement. All irrigation improvement costs will be the Lessee responsibility.

Environmental and Community Benefits

Active farming of the property provides multiple benefits including maintaining soil health, preventing land degradation, and supporting local agricultural economic activity. Responsible water management practices may also provide opportunities for floodwater management and groundwater recharge when appropriate.

Operational Capacity

Correia Custom Farming Inc. operates modern agricultural equipment capable of managing large acreage efficiently. The company has experienced personnel, tractors, planting equipment, irrigation systems, and harvesting equipment necessary to maintain and farm the property effectively. I am actively engaged in regional water management and groundwater sustainability efforts. I currently serve as Chairman of the Advisory Committee for the Mid-Kaweah Groundwater Sustainability Agency (GSA) and serve on the Board of Directors for the Persian-Watson Ditch Company. My involvement in these organizations provides valuable insight into regional water policy and SGMA implementation. Compliance with the Sustainable Groundwater Management Act (SGMA) is a critical factor in the long-term success and sustainability of agriculture in Tulare County, and I am committed to responsible water management practices that support both agricultural productivity and groundwater sustainability.

Financial Proposal

Correia Custom Farming Inc. proposes a lease structure that supports long-term stewardship of the property while allowing the lessee to make necessary investments in agricultural infrastructure. The proposed payment structure is designed to allow for necessary infrastructure improvements that will enhance the long-term value, productivity, and overall condition of the property. The proposed lease payment structure is **\$25 per acre annually for an initial five (5) year term, with two (2) additional five (5) year renewal options**, allowing for a potential total lease term of fifteen (15) years. The proposed lease rate reflects the current condition of the property and the level of investment required to bring the land into productive agricultural use. The lessee agrees to transfer **ten percent (10%) of any flood-release surface water applied to the property** to the City of Visalia's water account. This provision provides a direct water supply benefit to the City and creates the potential for additional financial value beyond the annual per-acre lease payment, depending on the availability of flood-release water. This arrangement provides the City of Visalia with an opportunity to increase its water resources without requiring any capital investment or operational responsibility. Allocating a portion of flood-release surface water to the City's water account helps strengthen the City's long-term water portfolio while also supporting regional groundwater recharge and SGMA sustainability objectives. This creates a mutually beneficial outcome by improving groundwater reliability for the surrounding area while providing the City with additional water assets that may hold long-term financial and strategic value. This lease structure allows the lessee to invest in irrigation infrastructure improvements that will enhance the long-term productivity, value, and condition of the property. These improvements will provide lasting benefits to the City of Visalia while ensuring the land is actively maintained and responsibly managed. Establishing a reasonable lease rate encourages responsible stewardship and allows for the capital investment necessary to improve the property over time.

Compliance and Certifications

Correia Custom Farming Inc. will comply with all City of Visalia proposal requirements including non-collusion affidavits, equal employment compliance, ownership disclosures, ADA compliance, and all applicable state contracting certifications required under the RFP.

Conclusion

Correia Custom Farming Inc. has been actively managing the property for the past two years to establish a winter wheat crop. During this time, we have invested considerable effort into improving the condition of the property, including clearing weeds and debris, improving access roads, and addressing general maintenance needs.

Our family farming operation has been based in Tulare County for more than 30 years and has built a strong reputation for maintaining agricultural properties with a high level of care and attention to detail. We have successfully rehabilitated and managed several agricultural properties in the region, bringing them back into productive use while maintaining their long-term value.

In addition, we currently farm property adjacent to the City of Visalia wastewater treatment facility and have developed a positive working relationship with City staff. Open communication and transparency are core values of our small family farming operation and have been key factors in our long-term success.

Having already invested time and effort into improving the property and gaining familiarity with its condition, access, and management needs, we are well positioned to continue responsible stewardship of the land moving forward.

Correia Custom Farming Inc. is committed to maintaining the City's property in excellent condition while supporting productive agricultural use. As a long-standing local farming operation, we take pride in responsibly managing land within our community and look forward to continuing a productive partnership with the City of Visalia.
