Mural Application

1) Mural Detail - Please explain the nature of the mural including its size and materials to be used:

Our mural will be painted on the cinder-block façade of the East side, street facing wall of our Lover's Lane property. This wall measures 32'8"w x 13'h with a total square footage of 416 sq. ft. Once primed, the wall will be primed and painted blue. We will transfer our design via grid drawings. Teams of experienced artist volunteers will execute the design along with guided groups of general volunteers, overseen by mural artist Katy Kemalyan. Upon completion, the mural will be sealed with Perma-guard sealant.

2) What is the purpose, meaning and/or significance of the proposed mural and why is it important to share with the community?

Habitat for Humanity of Tulare/Kings Counties is the local chapter of Habitat for Humanity International. Habitat aims to ensure decent shelter for all through sustainable and transformative community development. Our goal with this mural is to refresh our building's façade, increase visibility, aid way-finding, and communicate our mission with the public. The design is based on Habitat's own logo, and signature Pantone shades of blue, gray, and green. Through images of tools, building materials, articles of the home, and locally inspired elements like poppies and giant sequoias, the design will suggest a narrative of community building and recycling.

3) What is the timetable to commence and complete the subject mural?

Upon approval, painting will be scheduled to be complete within 20-30 days of approved start date.

4) Please give a brief biography of the individual(s), group(s) or organization(s) that will install the mural along with the artistic credentials of the artist who prepared the mural design:

Katy Kemalyan is a former Kings Art Center art teacher, graduate of Southwestern University's Bachelor of Fine Arts - Painting program and is currently serving a term as an AmeriCorps Volunteer Infrastructure program at Habitat for Humanity of Tulare/Kings Counties. Part of her goal in organizing this mural is to combine her passions of community service and visual arts; large groups of volunteers from all over the Valley, coordinated by Katy will execute this mural, making it a truly community-based effort. Katy's experience in mural painting includes 4 self-designed and painted murals within Kings County as well as a dozen or so that she has helped on over the years.

5) Please explain who will be responsible for the murals maintenance:

The mural will be maintained by Habitat for Humanity of Tulare/Kings Counties; Katy Kemalyan will be contacted to repair any major vandalization.
