Mural Application

1) Mural Detail - Please explain the nature of the mural including its size and materials to be used:
This mural will be approximately 14.625' x 4.5'. It will be painted on pellon material in studio and installed on site. The paint used is Nova paint and the glue will be Nova Gel from the company Nova Colors. Mural shield will be used for
UV control and a wax for graffiti protection.
2) What is the purpose, meaning and/or significance of the proposed mural and why is it important to share with the community? The mural is meant to be a patriotic and nostalgic look at farm life in Tulare County, with a hillside backdrop reflecting eastern Tulare County with oak trees,
a rustic barn with a large American flag, and a multi-generational family working on old tractors while off in the distance a citrus grove
undergoes cultural practices with a topping machine moving down a row. It's meant to symbolize the generations of farm life and how
life continues on as knowledge and farm life passes down from one generation to the next.
We are also dedicating a new flag pole at the building, and would like this mural to be the backdrop to the new flag pole installed. We believe the farm community needs to be celebrated in more ways, and the generational knowledge and familial ties that bind farms together is an imagery worth sharing with our community. This would face on a south wall of our building, and beautify a brick wall that visitors pass daily
3) What is the timetable to commence and complete the subject mural? The mural can be started in beginning of May 2025 and be installed by the end of July 2025.
4) Please give a brief biography of the individual(s), group(s) or organization(s) that will install the mural along with the artistic credentials of the artist who prepared the mural design: Colleen Mitchell-Veyna from Veyna Design Studios, Inc. will be painting the mural on pellon canvas.
Kelsey Gilles will be installing it.
Colleen has owned Veyna Design Studios Inc. 2005. The company has painted many murals throughout the central valley and elsewhere. Most of the murals are for businesses, facilities, cities, schools.
Kalany Cillan has callaborated with Vayna Dagign Studies for the last 10 years or as. She and Callan have
Kelsey Gilles has collaborated with Veyna Design Studios for the last 10 years or so. She and Colleen have collaborated on all murals completed within the last 10 years.
Farm Bureau began in Tulare County in 1917, and we are a non profit agricultural membership association representing family farms.
5) Please explain who will be responsible for the murals maintenance: Tulare County Farm Bureau will be responsible for maintenance, with consultation from the artist. This is our second mural, we had Veyna Designs install one
for our centennial in 2017, and it has been sealed and cleaned once every 5 years and continues to look amazing.
