


#### ITEM 1: QUESTIONS/RESPONSES

Q1: I was wondering if you folks have an image of a complete overhead street name blade with the attached angle iron on the back? Your attached drawing makes sense for the most part, but we are slightly confused about the top view and the holes that are drilled 1/3 of the way over.

R1: On overhead street name blades, the holes a third of the way over from the right side are to line up with the holes in the hardware that the sign is to be mounted to (hardware that is already in the field.). The pre-drilled holes shall be 4 7/8 inches apart as shown in Exhibit D-3.

Please see the following images of the back of an overhead street name blade where pre-drilled holes are to be made:





- Q2: The license / Tax certification is required after the project is awarded, however we see in EXHIBIT "A" BID FORM on page 12 of the attached doc, is required to fill in the details.
- R2: No Contractor's license is required for this bid and this section on page 12 under Contractor's Permit Information may be left blank. However, if a bidder has a Contractor's license, this can be noted in this section.

A City of Visalia Business Tax Certificate is not required to submit a bid and this section on page 13 may be left blank. The awarded bidder may need to obtain a tax certificate if working in Visalia or is transacting business within Visalia. Please contact the Business License Division at 559-713-4326 to confirm whether you would need a tax certificate if the contract were to be awarded to your company.

- Q3: What will be the minimum order quantity per order? As this is a bi-annual purchase what will be the quantity per order?
- R3: There is no set minimum quantity placed per order. Page 11 of the RFB document displays the Bid Form chart showing an <u>estimated annual quantity</u> of 936 signs to be purchased in two (2) orders annually. The estimated annual quantity divided by 2 could be used as a rough estimate of each order. Our goal is to place two (2) orders per year, but at minimum we would place at least one (1) order per year.
- Q4: Do you have an estimated budget?
- R4 The estimated budget is \$40,000 annually for street name signs.
- Q5: The quantity total mentioned in "Bid Form" is said to be 936 and in "Cost Breakdown" it is 404. Just confirm if the 404 is for post mounted signs and adding to it in the bid form remaining quantity is for overhead signs right? If it is not like that please correct me.
- R5: The 936 listed on the bid form is an <u>estimated annual quantity</u> of street signs including post mounted and overhead street name signs. Exhibit D-1 (also being referred to as the "Cost Breakdown") is a <u>sample</u> of the list of street signs to be ordered. In that sample, it showed 404 post mounted signs to be ordered. This quantity may change when placing the order with the awarded bidder.

Please use the estimated annual quantities listed on the bid form to determine your unit costs. The quantities given on the bid form are approximate only. They are given as a basis for comparison of bids. The City of Visalia does not, expressly or impliedly agree that the actual amount of product being purchased will be the same as the estimated annual quantities listed on the bid form. The City reserves the right to increase or decrease the amount of product it orders at the awarded bidder's stated unit costs.

- Q6: Does the city require any Buy American product or any specific product sourcing requirement?
- R6: For this RFB, the City does not require Buy American product and there is no specific product sourcing requirements.

O7: What will be the delivery timeline for order?
