A RESOLUTION OF THE BOARD OF DIRECTORS OF THE GOSHEN COMMUNITY SERVICES DISTRICT APPROVING A NEW WASTEWATER SEWER AGREEMENT BETWEEN THE CITY OF VISALIA AND THE GOSHEN COMMUNITY SERVICES DISTRICT, REPLACING AGREEMENT NO. 95-2 DATED JUNE 5, 1995

WHEREAS, the Goshen Community Services District (“District”) provides sewer services within its jurisdiction; and

WHEREAS, the District previously entered into a Wastewater Sewer Agreement with the City of Visalia, identified as Agreement No. 95-2, dated June 5, 1995; and

WHEREAS, the District and the City of Visalia desire to enter into a new Wastewater Sewer Agreement to update and replace the terms and conditions of the prior agreement; and

WHEREAS, the Board of Directors has reviewed the proposed new Wastewater Sewer Agreement and has determined that it is in the best interest of the District and its residents to approve and enter into said agreement; and

WHEREAS, at its regularly scheduled meeting on May 28, 2026, the Board of Directors of the Goshen Community Services District discussed and duly considered the proposed agreement;

NOW, THEREFORE, BE IT RESOLVED AS FOLLOWS:

1. The Board of Directors hereby approves the new Wastewater Sewer Agreement between the City of Visalia and the Goshen Community Services District.
2. The new agreement shall replace and supersede the prior agreement identified as Agreement No. 95-2, dated June 5, 1995.
3. The General Manager (or Board President, if preferred) is hereby authorized to execute the agreement on behalf of the District and to take any and all actions necessary to implement its terms.

THE FOREGOING RESOLUTION was adopted upon the motion of Director Valdez, seconded by Director Correa, at a regular meeting of the Board of Directors of the Goshen Community Services District held on May 28, 2026, by the following vote:



8.9 Entirety. This Agreement merges and supersedes all prior negotiations, representations and preliminary or other agreements between the parties hereto relating to the subject matter hereof, and constitutes the entire contract between the City and District for the acceptance and treatment of wastewater from the District. This Agreement shall control in the event of any conflict or inconsistency with any other provisions of any City Ordinance or any rules, resolutions, or regulations incorporated therein or adopted pursuant thereto.

8.10 Counterparts. This Agreement may be executed in one or more counterparts, and all so executed shall constitute one contract, binding on the parties, notwithstanding that all parties are not signatory to the same counterpart.
